

The District Consumer Protection Council shall meet and when necessary but not less than two Meetings shall be held every year.

The aims, objectives and function of the Council are to promote and protect the rights of the consumer as follows:

1. The right to be protected against the marketing goods which are hazardous to life and property.
2. The right to be informed about the quality, quantity, potency, standard and price of goods so as to protect the Consumer against unfair trade practices.
3. The right to be assured whenever possible, access to a vacancy of goods at competitive price.
4. The right to be heard and to be assured that consumers' interest will receive due consideration at appropriate forums.
5. The right to seek redressal against unfair practices or unscrupulous exploration of consumers.
6. The right to Consumer Education.


